NATIONAL MECHANISM

- Council for Anti-Trafficking in Persons and Anti-Smuggling of Migrants. (MAPO)
 - Source of Establishment:
 - Anti-Trafficking in Persons Act 2007 which came into force on 28 Feb, 2008. Following the Anti-Trafficking in Persons (Amendment) Act 2010, to also include the smuggling of migrants, MAPO is now known as the Council for Anti-Trafficking in Persons and Anti-Smuggling of Migrants.
 - Chair: Ministry of Home Affairs Secretary General.
 - Council Members:
 - Attorney General
 - Min. of Foreign Affairs; Home Affairs; Human Resources; Transport; information, Communication and Heritage; Min. of Women, Family & Community Development
 - IGP, DG of Immigration, DG of Customs, DG of Maritime Enforcement,
 - 5 NGO reps
 - Objective: To make Malaysia internationally accredited as being free of illegal activities in connection with human trafficking and smuggling of migrants. Hence, MAPO's main function is to prevent and eradicate human trafficking and migrant smuggling crimes through comprehensive enforcement of the Anti-Trafficking in Persons (Amendment) Act 2010.
 - Ministry of Women, Family & Community Development (MWFCD) is the Chair of Committee of Care and Protection, responsible to Care and Rehabilitate Victims of Trafficked Persons until Revocation of Order is made

LEGAL MECHANISM

1. Act: Anti-Trafficking In Person and Anti-Smuggling of Migrant Act 2007 (Act 670) (ammended 2010)

- Section 44(2)
 - Interim Protection Order (IPO)
 - -14 days
- Section 51(3)
 - Protection Order (PO)
 - i) Citizen/Permanent Resident = not exceeding 2 yrs
 - ii) Foreign National = not exceeding 3 months

- PROVISION OF FREE HEALTH SERVICES & TREATMENT
 - Health screening/ medical check up/ maternity check up;
 - STD/HIV/TB/ Hepatitis treatment screening and treatment;
 - Regular maternity treatment & services for mom and baby;
- PROVISION MENTAL HEALTH SERVICES & COUNSELLING
 - Individual and Group Counseling by registered professional counselors from government and NGOs;
 - Mental Health Assessments, Psychological and Psychiatric Services
 - Weekly basis at the SH (program are voluntary base)

PROTECTION SERVICES/...3

PROVISON OF FACILITATION TO COURT & LEGAL PROCEEDINGS

- SH will facilitate to produce the victims In Court upon receiving subpoena;
- providing escort service and transportation to court;
- hotel accommodation, foods and drinks;

PROVISION OF EDUCATION AND AWARENESS

- At point of IPO, victims are given orientation and education of the shelter and the protection program;
- Education regarding prevention and awareness of human trafficking;

PROTECTION SERVICES/...4

COORDINATING VISITS BY EMBASSIES

- Respective Embassies will be notified of their citizens under care;
- Victims are allowed to meet with officials/representatives from their Embassies

COMMUNICATION

 One phone call is allowed every month to family members.

OTHER ACTIVITIES AT WOMEN SHELTER HOMES

- Faith Sharing (Islam/Christian/Buddhist)
- 2. Religious classes
- Art & Culture Dancing & Singing

- Handicrafts classes
