## Institutional Mechanisms for the Advancement of Women

### Numbers Speak

-  119 Gender and Development (GAD) Focal Point Systems are in place in national government agencies as of 2014
-  41 Local Government Units able to adopt GAD Codes (GREAT Women Project sites)
-  8 Comprehensive development plans and 3 local revenue codes were integrated with gender perspective (GREAT Women Project sites)
-  At least 4 development plans being implemented at the national level have incorporated gender dimensions:



### Key Policies and Programs Adopted

The Philippine Commission on Women has been focusing on partnership, convergence and advocacy with other government, NGO/CSO/academe and other development partners, to broaden its influence and reach, and to strengthen capacity and capability of its government partners in **gender mainstreaming**:

**a. Building competencies on gender and development and development of gender analysis tools and guidelines (technical assistance provision)**

**b. Issuance of gender related policies and lobby for gender related-laws, including the integration of gender in development plans (policy development) and**

**c. Data base and systems development for monitoring and evaluation**

GAD Planning and Budgeting continues to be the main vehicle for implementing and monitoring the Philippine government's legal/policy commitments to gender equality women's empowerment and women's human rights

Presently, the GAD planning and budgeting process is supported by the presence of clear guidelines and references, the modules for capacity development and the audit of GAD funds by the Commission on Audit
