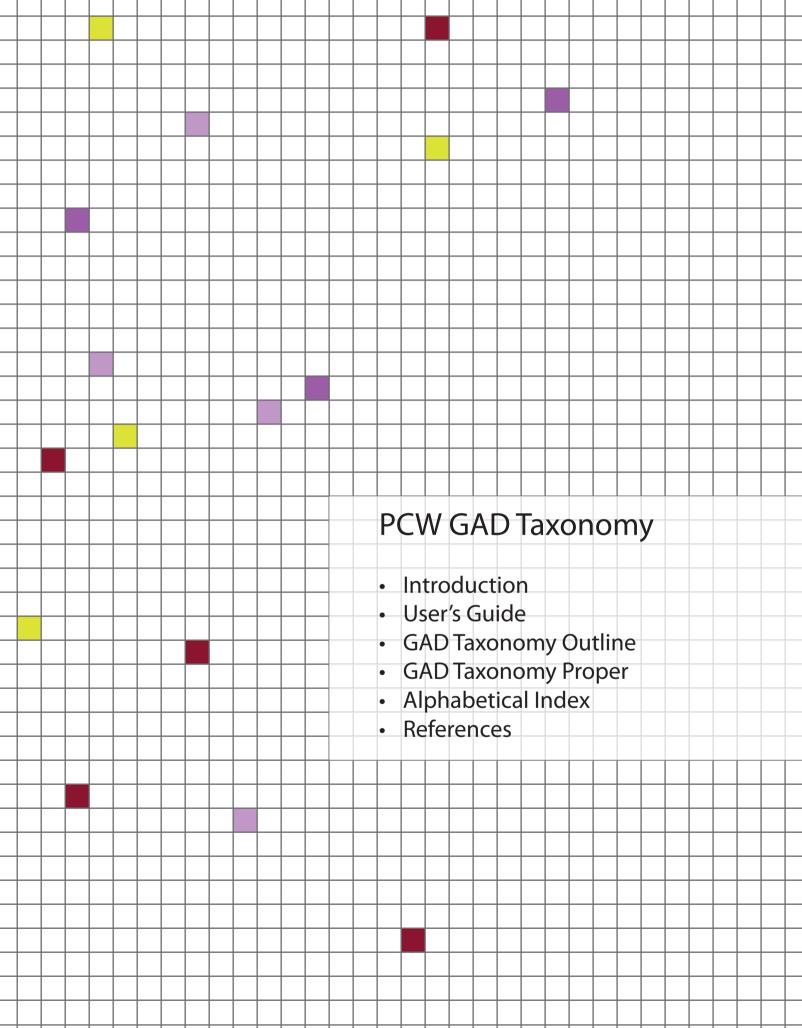
Supported by the Canadian International Development Agency (CIDA), the GREAT Women Project is a five-year project creating a gender-responsive enabling environment for women's economic empowerment (WEE). PCW Taxonomies help organize and expand available GAD and WEE information resources for women's empowerment.

Recognizing the importance of these tools, PCW recommends its two-volume PCW Taxonomy to its partner organizations and individuals, for systematic filing, organizing and expanding of print or electronic information resources in the area of gender and development. The first volume, the PCW GAD Taxonomy is an arrangement of terms and concepts related to GAD, which is highly useful for government, non-government/civil society organizations, academic institutions and individuals interested on gender and development.

The second volume, the PCW Organizational Taxonomy, is a records/file management tool and primarily developed for the organization's internal use. It is recommended for use among PCW divisions in uniform filing, organizing, and managing their documents and records.

PCW hopes to contribute to the growth and efficient management of information resources relating to gender and development among our partners, through their continuing use of these taxonomies. We encourage partners to make use of these knowledge products to enrich their information resources on GAD.

Philippine Commission on Women GAD Taxonomy INTRODUCTION & USER'S GUIDE

PCW developed taxonomies to help in organizing and classifying information resources accessed within the organization and by PCW stakeholders such as the Government, non-government/civil society organizations, academic institutions and individuals interested in gender and development.

Taxonomy is synonymous to a classification scheme. It is a tool which helps in classifying objects, places, and concepts in a hierarchical structure - from the general to specific.

The Gender and Development (GAD) Taxonomy will help in classifying, organizing and accessing information and knowledge products on GAD, especially those produced by PCW. It is divided into two parts: 1) the outline of main categories and major sub-topic under each category, 2) the taxonomy of main categories until the most possible, specific sub-topic under each category.

The GAD Taxonomy consists of 11 main categories, with each category represented by an alphabet, i.e., A, B, C, etc. Each main category is further broken down into subdivisions. The arrangement of the subdivisions under each main category is from general to specific. As a category is broken down into specific topics, the classification is extended with the use of Arabic numbers and decimal points. For example:

Note that some of the broad concepts may not necessarily be broken down into specific topics. However, related topics are usually placed as a scope note under the term in italics and are enclosed in parentheses as shown below:

C.15.01 Economic violence (includes withdrawal of financial support, deprivation, destruction of household property, controlling victims' resources, and other economic forms of abuse)

"Economic violence" covers forms of economic violence like as stated above.

Some topics may be associated or related to some others. Cross references are immediately placed after the topic in italics and in parentheses, preceded by the abbreviation "Cf.". For example,

D.10.03 Ecofeminism (Cf. A.05.01 Ecofeminism)

"Ecofeminism" is a specific topic that is subsumed under the subdivision "Environment and natural resources" (D.10), which falls under the main category of ECONOMIC DEVELOPMENT (D). However, it is also a specific topic under the subdivision "Feminism" (A.05) which is also subsumed under the main category of GENDER (A). This means that some aspects of "Ecofeminism" may be classified under "Environment and natural resources" while its other aspects may be classified under "Feminism". The user is given the cross reference to determine the relevant classification number depending on the information being searched.

Note that this taxonomy is a tool for classifying, organizing and accessing information and knowledge products and does not contain the actual information.

Users must note that this taxonomy uses controlled vocabulary. It is advised to first use the main category to find the appropriate topic being searched.

This taxonomy may be used for printed documents, audio-visual or multimedia materials, and web-based materials on gender and development.
