UN MILLENNIUM DEVELOPMENT GOALS

The Millennium Summit 2000 (Philippines) reaffirmed the commitment of UN member states and governments as they adopted the UN Millenium Declaration that revives the global commitment to seek peace, uphold human rights and reduce poverty worldwide. One specific goal embodied in these key objectives is the promotion of gender equality.

UNDP FRAMEWORK ON GENDER, POVERTY AND GOVERNANCE

Through its creation of APGEN (Asia-Pacific Gender Equality Network), UNDP seeks to contribute to building the capacity of governments, with specific focus on the Asia-Pacific Region, to formulate and implement gender-responsive poverty reduction strategies and economic policies.

PHITSANULOK DECLARATION ON THE ADVANCEMENT OF WOMEN IN LOCAL GOVERNMENT

The draft declaration's general objective is to increase the representation and participation of women in power and decision-making.

FRAMEWORK PLAN FOR WOMEN

The National Commission on the Role of Filipino Women (NCRFW), the Philippine government's national machinery on women, has a blueprint that prioritizes three areas of concern within the next three years: 1) women's economic empowerment; 2) protection and upholding of women's human rights; and 3) gender-responsive governance.

WOMEN IN LOCAL GOVERNANCE

The identification of current issues in gender and governance, particularly local governance, jumpstarts the discussion from which ensues the basis for a draft plan of action for the National Summit of Women Local Chief Executives and Legislators.

WELCOME TO THE NATIONAL SUMMIT OF WOMEN LOCAL CHIEF EXECUTIVES (LCES) AND LEGISLATORS: BUILDING PARTNERSHIPS TOWARDS GENDER RESPONSIVE LOCAL GOVERNANCE

Herstory

The build-up to our Summit today goes way back to June 2001 when the Asia Pacific Summit of Women Mayors and Councilors took place in Phitsanulok, Thailand. It had 200 participants from 24 countries, with an impressive delegation of 34 coming from the Philippines. It was at this conference that the Phitsanulok Declaration on the Advancement of Women in Local Government was adopted by the participants. The Declaration calls for the conduct of national summits of women mayors and councilors:

- to create awareness
- to identify needs, strategies and resources
- to effect changes in the policy environment towards advancing women's participation in governance

The UN Economic and Social Commission for Asia and the Pacific (UNESCAP) was tasked to provide strategic technical assistance in convening these country-level summits. Subsequently, a guideline was developed that outlines the recommended steps for organizing the National Summit.

At the Summit in Phitsanulok, NCRFW made the commitment to spearhead the organization of a National Summit of Women Mayors and Councilors in the Philippines. For this purpose, an Initiating Committee was organized whose tasks were:

- to convene the Preparatory Committee which shall determine the substantive content of the envisioned National Summit
- to recommend a monitoring system that will serve to follow up actions taken after the National Summit

With NCRFW at the helm of the project, while at the same time taking its cue from the Guidelines developed by UNESCAP, the Initiating Committee was convened in meetings held on 9 December 2002 and 9 January 2003.

The outputs of the Initiating Committee are the following:

- Members of the Committee have been identified
- Its Secretariat was named: the UP Center for Women's Studies (UCWS) and the Center for Local and Regional Governance, UP National College of Public Administration and Governance (NCPAG)
- 3. The design of the Preparatory Committee Meeting was drawn
- 4. Production of the list of members of the Preparatory Committee with its accompanying criteria for the selection of names in the list
- 5. Proposal for a tentative design for the National Summit of Women Mayors and Councilors.

The build-up to today's Summit continued with the holding of the Preparatory Committee (PrepCom) Meeting on 20–21 February, 2003 in SEAMEO-Innotech, Quezon City.

The Prep-Com participants constituted of women mayors and councilors. During the two-day workshops and plenary sessions, the delegates reviewed the issues and strategies that are identified in the Frameworks of Development for Women, a compilation of five documents serving as working papers for the conference.

Based on the recommended strategies in these documents, the participating body also developed specific interventions and their corresponding mechanisms for monitoring and linkaging.

As the PrepCom came to a close, a Draft Resolution that articulated Implementing Action/Strategies was completed. This Draft Resolution will be presented at the future National Summit of Women Mayors and Councilors.

The participants to this summit have grown and included other women involved in governance. The three-day conference that starts today is now the National Summit of Women Local Chief Executives and Legislators. Its objectives are:

- to raise awareness on issues related to gender mainstreaming and women's participation and representation in local governance;
- to review, enhance, approve and adopt a Declaration that addresses the issues identified in the following major documents: Framework Plan for Women, Phitsanulok Declaration on the Advancement of Women in Local Government, UN Millennium Development Goals, UNDP Framework on Gender, Poverty and Governance, and Women in Local Governance: Current Issues and Concerns for the Philippines;
- to build the capacities of women local chief executives and legislators in developing and implementing GAD policies, programs and projects at the local level; and
- to generate commitment from women local chief executives and local legislators for the pursuit of gender mainstreaming and the implementation of the Declaration.

Canada, through CIDA, supports the poverty alleviation program of the Government of the Philippines. We believe that gender-responsive governance is a condition for good governance and is critical in addressing poverty. Gender equality is a cross-cutting theme in all CIDA projects, and promoting women's increased participation in politics and decision-making is one of the objectives of CIDA's Gender Equality Fund, one of the co-funders of this Summit.

CIDA also supports several projects and programs that address local governance, the primary one being LGSP—the Local Government Support Program—which many of you may already be aware of. In working with 205 LGUs in Mindanao and Western Visayas, LGSP aims to promote efficient, transparent, accountable and responsible governance, recognizing that mainstreaming gender issues is a crucial facet and essential quality of responsive local governance. During the Summit, LGSP will be launching their manual entitled, Freedom from Fear: Establishing a Quick Response Team to Violence Against Women. Freedom from Fear is designed to be a capacity building tool and a replication manual to guide local government. A helpful companion piece to Freedom from Fear is the handbook

entitled, Barangay to the Rescue, another CIDA-funded publication, produced by DILG and NCRFW to help barangays handle cases of domestic violence. Another recent NCRFW publication supported by CIDA is the primer for Local Chief Executives entitled, Making LGUs Gender-Responsive. All these initiatives in providing local government with knowledge products and tools represent an important stride in our continuing efforts to enshrine gender-responsiveness as a hallmark of good governance.

In our governance projects, we try to ensure that government and local civil society groups take the ownership and leadership in these initiatives, and that collaboration and partnerships are observed. As gender advocates, we try to involve men as much as women; we know there are many men who support women's empowerment. This way, we are able to gain more allies, maximize our resources and foster greater sustainability.

The summit's goal—to agree on a set of strategies to increase women's participation in electoral politics and enhance their capacities as transformative leaders—is indeed a challenging mandate. Perhaps even more daunting will be implementing the strategies, but if all continue to work together, progress can be made.
